Pitching Your Boss on Paying for Your ASCE Membership

I am a firm believer in the "elevator pitch". I have used this technique on many occasions throughout my career. When I approach people as to why they are not members of the American Society of Civil Engineers, many times, their answer is, "My Company won't pay for it". This is unfortunate because ASCE has so many benefits. It would be easy to simply provide them with the "101 Ways to Benefit from ASCE", but this isn't really effective. They may not read it, they may not understand it, and most likely (since reading it isn't billable time) it will sit on their desk unread. But if you take the time to engage them, and explain the advantages of the membership of ASCE, they are more likely to see things your way and pay for your membership.

An elevator pitch is a 60 second speech you have to "sell" or inform someone of your position. In this case, it might be something you catch your boss with when he or she is in the break room or in the hallway. In practice you typically have just 60 seconds to leave an exciting, impactful, and meaningful impression about what you want from a person. You need to make the 60 seconds count! Each pitch should be tailor made to who you are trying to "sell" to, so I am not going to give you an exact dialog to memorize, but I'm going to give you an outline to help you create something for yourself.

Every elevator speech requires you to engage the person, and make them care. As a boss/supervisor, I care about profit. As engineers we use numbers to come to conclusions. As a boss/owner/supervisor, profit is an easy way to gauge success, and failure. Unnecessary expenses take away from profit, and are a hard pill to swallow. However, expenses that lead to someone being more productive, and increasing profit are easy to accept. The first element of your elevator speech should be to show how being a member of ASCE will actually save them money, educate you, make you more efficient, and increase their profitability. Here are a few facts to help with this part of your speech.

FREE PDH's

In Utah, a licensed professional is required to complete 30 hours of continuing education per two year renewal cycle. Each PDH costs approximately \$150. So your company will most likely have to spend \$4500 every two years to keep your license current. With your ASCE membership, you get 5 free PHD's each year; that is a \$750 savings each year. Each branch meeting you attend gives you 1 additional PDH. The cost for the branch meetings is an average of \$20/meeting (there are 9 meetings a year); that is a savings of \$130 per meeting. Webinars that give you 1 PDH cost \$159 for non-members, but for members they are only \$99. Remember, these are webinars, so theoretically the entire office could attend and each attendee would get 1 PDH. In short, your ASCE membership costs approximately \$250 per year. So in a two year cycle, it costs \$250 dollars for your membership/year and the cost of 9 meetings/year and one webinar/year you'll save \$3400. This is money that your company would have to pay to keep your license current anyway. So you can suggest to your boss/supervisor that rather than spend the \$4500, they could simply spend some of that money already budgeted on an ASCE membership that also has many more membership benefits.

PUBLICATION DISCOUNTS

Codes and standards are what we all use every day. When the code cycle is complete, we need to purchase another set of codes. ASCE is one of the largest Standard Development Organizations in the world. Your company is going to have to purchase codes to stay in business, so your company has budgeted to purchase these codes. ASCE gives discounts on all their codes and publications. Here are a few examples of the money you would save by being a member:

- ASCE 7-10 Minimum Design Loads for Buildings and Other Structures: Non-member price - \$165; Member Price - \$123.75 (a savings of \$41.25)
- ASCE/SEI 41 Seismic Evaluation and Retrofit of Existing Buildings: Non-member price
 \$220; Member Price \$165 (a savings of \$55)

These two publications alone save you almost half of your membership fee. Less expenses, mean more profitability.

CONTRACT DOCUMENTS

Lawyer fees can range from \$255 to \$520 per hour. We all know that the best way to avoid a lawsuit is to have a good contract. Why pay an attorney upwards of \$520 per hour to reinvent the wheel? As a member of ASCE you can download standard contract documents that represent the latest, and best thinking in contractual regulations between all parties involved in engineering design, and construction projects. At ASCE Contract Documents, you can download documents that experienced engineering professionals, professional liability and risk management experts, and legal counsel have prepared to reduce your conflicts, and avoid litigation. The savings here are legitimately in the order of thousands of dollars and priceless in terms of peace of mind.

MARKETING/NETWORKING

People have personalities and perspectives that influence their performance and the way they communicate on teams. In my experience, people don't simply hire technically proficient companies; people hire people. Engineers hire other engineers. Civil engineers, hire structural engineers; structural engineers hire geotechnical engineers; geotechnical engineers hire civil, and on goes the cycle. Since we know people hire people, one of the best ways to market your company is to introduce yourself to the leaders of this profession. Become known as a leader in this profession. The easiest and best way to do this is to become a member of ASCE, and attend the meetings. Once people see you, get to know you, they are more apt to hire you and/or recommend you and your services to their dients.

The overall theme of your elevator speech to your boss/supervisor is that he or she, and your company are going to be spending this money anyway. The money he or she spends on your ASCE membership will not only save you money and potentially increase your profitability, but it will make you a better representative of the company. This in turn will bring in more work, which brings more profit. Basically, your boss/supervisor can't afford to not pay for your membership.
